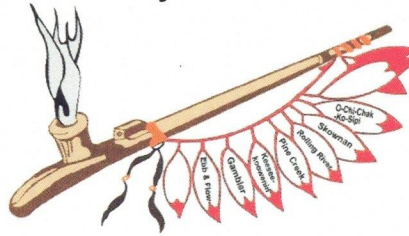

Under the auspices of West Region Treaty 2 & 4 Health Services, the Community Based Water Monitor (CBWM) will be responsible for water sampling, testing and reporting; working directly with the Environmental Public Health Officer (EPHO) withing the EPH - Drinking Water Safety Program.

Duties: (Summary)

- Collect water samples from homes and public buildings as directed by the EPHO.
- Process water samples using lab equipment provided.
- Maintain records of all the water samples taken.
- Forward records to the EPHO weekly; copies to the Band Office and Health Director.
- Maintenance of all equipment in relation to the Drinking Water Sampling Program.
- Mandatory attendance at training sessions and meetings as arranged by the EPHO.

Qualifications:

- Minimum Grade 10 requirements.
- Must have excellent organizational skills.
- Must have Class 5 Manitoba Driver's License.
- Must have a reliable vehicle.
- Understanding and knowledgeable of First Nation cultural customs.

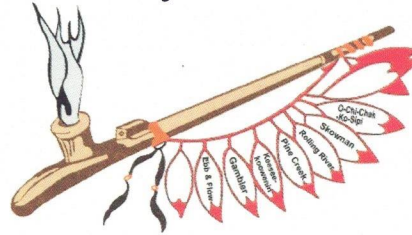
